Someday, the combined company may have a new name that best represents our larger vision to be the leading provider of tech-enabled charitable giving solutions.

Q: Who will lead the new company?

Gary Pforzheimer and the same leadership team will continue to run the PG Calc division. Together with <u>Foundation Source</u>, our combined company will be led by <u>CEO Joe Mrak</u>, a highly respected leader in the financial technology and wealth management industries. The combined company is primarily owned by a prominent private equity firm, <u>GTCR</u>.
