Stay In Touch

A legacy gift represents a long-term relationship between your organization and the donor. While it is likely that your organization will remain in the donor's will once that philanthropic intent is expressed, there is no guarantee.

You can take the uncertainty out of this equation by practicing well-organized and purposeful stewardship of your bequest donors. That's where *Bequest Manager* comes in. Unlike general purpose databases or a collection of spreadsheets, *Bequest Manager* provides you with the tools you need to maintain ongoing communication with donors, family members, and advisors.

Manage the Process

The road to a realized bequest is a long one, and there are many potential barriers along the way. This is especially the case during the probate process. Have you gotten a statement of assets from the estate administrator? Did the payment of local and state taxes diminish the amount of expected bequest distributions? Have all filings taken place on time and as required? Your objective is to ensure that your organization receives all that it is entitled to, as quickly as possible. With *Bequest Manager*, you can keep track of the myriad issues that need your attention during probate and ensure that you maintain ongoing communication with the donor's estate.

Bequest Manager Features

Bequest Manager is the only purpose-built legacy giving administration program available. With Bequest Manager, you have a centralized database from which to manage your legacy gifts, from first notification of gift intention to the final distribution of a realized gift. Bequest Manager is available as stand-alone software or as an optional module in the GiftWrap planned gift administration system. Because Bequest Manager is a hosted web application, you don't need to worry about installation or ongoing maintenance, and you can be confident that your sensitive program data is secure.

Data Management

- Captures and maintains full detail on all bequest intentions and realized gifts.
- Records multiple transfer types will, revocable living trust, beneficiary designation.
- Supports diverse asset types cash, stock, real estate, personal property, trusts, investment accounts, insurance policies, and more.
- Provides comprehensive tracking of gift status intention, notification, in process, in probate, in litigation, partial distribution, full distribution.
- Includes a range of date identifiers intention date, estate filing date, estimated and actual close dates.
- Provides ability to:
 - Record distribution amounts received and expected.
 - · Assign probability to each bequest intention.
 - Record calls, letters, emails, and changes to bequest status.

Document Management

- Maintains any form of electronic document, including wills, estate inventories, trust documents, etc.
- Associates documents with the correct organization, person, and gift records.

Enhanced Security

- Includes multiple hosting options, IP filtering, enhanced data masking, 2-factor authentication, and single sign-on access management.
- Supports Secure Key Management, based on Amazon KMS and CloudHSM, providing facilities for remote encryption key management.


Data Reporting and Analysis
