





Establishing an additional gift annuity this year would increase your fixed payments for life and provide you with an immediate income tax charitable deduction. It would also give you the satisfaction of enhancing the financial strength of State University.

For example, if you create another gift annuity this year with \$10,000 in cash, you will receive an income tax charitable deduction of approximately \$4,791 and additional annual payments of \$580 for the rest of your life. What's more, \$420 of the payments you receive each year will be tax-free for the first 12 years.




